Executive Summary

The J-CAP "Judicial cooperation for the enhancement of mutual recognition regarding probation measures and alternative sanctions" project aims to improve the execution of Council Framework Decision 2008/947/JHA of 27 November 2008 on the application of the principle of mutual recognition to judgments and probation decisions with a view to the supervision of probation measures and alternative sanctions (herein after FD 2008/947). This objective will be pursued via an awareness-raising approach and the development of practical materials to facilitate the execution of the instrument among judges, prosecutors, lawyers and probation officers.

The present deliverable (including the present document and videos), embedded in Task (T) 4.3- Set-up and integration of Judicial Talks content for training purposes – of Work Package (WP) 4- Convergence of practices towards a fluid implementation of FD 2008/947 at EU-level – is comprised of a set of 6 videos, including insights, experiences, guidance and short tutorials to assist professionals in the better understanding of FD 2008/947 and supporting their daily work when using the Framework Decision.



JUDICIAL TALKS

Overview

The 6 JUDICIAL TALKs videos are divided in 2 groups. The first comprises a set of interviews with practitioners delving into specific matters in the context of FD 2008/947. The second set of videos includes 3 tutorials designed to assist practitioners in their daily work. The interviews were recorded during the 2nd Transnational Awareness-Raising Symposium, on the 6th and 7th of September 2023, at the École National de la Magistrature (ENM)'s premisses. Indeed, the *in-situ* nature of the event provide the perfect opportunity for direct interaction between the interviewer and interviewee, which would not be as effective in an online scenario. The 3 tutorial videos were recorded *ad hoc* by consortium members European Strategies Consulting (ESC) and IPS_Innovative Prison Systems. After all videos were completed IPS developed the editing process the finetuned the final versions.

To assist in the interview process, dedicated draft structures for the interviews were developed by IPS, with the support of all partners. To ensure compliance with data protection, dedicated data protection consent forms were developed and signed prior to the interviews by all interviewees.

Finally, the 6 videos will be integrated into the online training platforms of the 2 Judicial Training Schools integrating the J-CAP consortium, ENM and IGO-IFJ. Additional promotion of these videos among EUMS's judicial training schools will be carried out.
